Proceedings of the Meeting

1. Minutes of the last meeting were read and confirmed.
2. The committee members discussed in detail the minimum course curriculum for undergraduate courses under CBCS as per the UGC guidelines and framed the B. Com Programme structure. w. e. f. 2020-21 - for first year.
3. After thorough discussion, the Committee recommended the following changes in the syllabus
(a) The paper on Secretarial Practice is replaced by Elements of Companies Act at B. Com. I sem.



- (b) Marketing Management of I sem and Business Communications of II sem are interchanged.
- (c) Titles of Business Economics - I & II are changed as Managerial Economics I & II.
- (d) As per the UGC guidelines on CBCS, it was unanimously resolved to introduce new component of 'Extra Curricular Activities' (ECA) to motivate the students to expose their talents. ECA has only Internal Assessment of 50 marks at all semesters and has no semi-end examinations. After thorough discussion, the BOS members evolved the policy of awarding marks on the basis of active participation of student in NSS/NCC/YRC/RRC/Cultural/any external activities.
- (e) The paper on Entrepreneurship Development is introduced in place of Computer Applications Business at B.Com. II sem.
- (f) The component of 'Value Education' is deleted from 'Indian Constitution & Value Education' and changed the title as 'Indian Constitution' at I sem.

4. The members BOS approved the updated panel of Q/p setters and examiners of all subjects of all semesters of B.Com.

The meeting concluded with the vote of thanks by the Head of the Dept. of Commerce.
